Sub: Matter related to permission given for a period not exceeding five years to Shivayogeeshwar Rural Ayurvedic Medical College and Hospital, Inchal-591102,TQ: Saudatti, Distt.:Belgaum, Karnataka under section 13A/13C of the IMCC Act, 1970 – Hearing Notice – reg.

Sir,

I am directed to refer the Ministry's letter No.R.17011/63/2015-EP (IM-1) for dated 15.07.2015 and order no. R.14011/47/2014& 13011/69/2014-EP (IM-1) dated 15.09.2015 to say that the aforesaid college was granted permission for a period not exceeding five years i.e. from the academic session 2015-16 to the academic session 2019-20 with 60 UG seats and 06 PG courses namely (i) Rachna Sharir, (ii) Rasashastra & Bhaishajya Kalpana (iii) Kayachikitsa (iv) Dravyaguna, (v), Shalya Tantra, (vi) Panchakarma, with 05 seats in each under Section 13C/13A of the IMCC Act, 1970.

- 2. The aforesaid college was inspected by the surprise visitation team in accordance with Rule 3 (2) of the Indian Medicine Central Council (Requirement of Minimum Standard for undergraduate Ayurveda colleges and attached Hospitals) Regulations, 2016 on 25.04.2018 and 26.04.2018 to ascertain the position/status of the ASU colleges and submitted the inspection report to the Central Government.
- 3. And on examining the said report in terms of the Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016, IMCC (Post Graduate Ayurveda Education) Regulations, 2016, provisions under the IMCC Act, 1970, other relevant regulations made thereunder, several fundamental deficiencies were observed which are adversely affecting the purpose of quality medical education. Therefore, the Ministry vide letter dated 21.06.2018 directed the college to rectify the deficiencies within a period of 20 days (i.e., 11th July 2018) and submit the compliance report otherwise it was further informed that the permission granted for a period of five years shall deemed to be withdrawn.

- 4. In response to the Ministry's letter dated 21.06.2018, the Principal, Shri Shivayogeeshwar Rural Ayurvedic Medical College and Hospital, Inchal-591102,TQ: Saudatti, Distt.:Belgaum, Karnataka has submitted a compliance report with reference no. SSRAMC/CO/2018/463 dated 07.07.2018 to this Ministry which was received on 09.07.2018. However, on analysis of the submitted compliance report it appears that, the college is still not fulfilling the following requirements:
 - I. Only 22 eligible teachers are available against the requirement of 42 teachers.
 - II. Only 11 HF in 09 dept. are available against the requirement of 21 HF in 14 departments.
 - III. Only 08 dept. having 01 P/R+01 L against the requirement of 13 dept.
 - IV. Requirement of Professor in Shalya Tantra and Kayachkitsa for PG course is not available.
 - V. Only 01 Lecturer in Kayachikitsa is available against the requirement of 1P+1R+1L.
 - VI. No Yoga teacher and Biostatistian is available.
 - VII. Only 04 consultants are available against the requirement of 08.
 - VIII. Numerical teacher student ratio not available in 03 departments.
 - IX. Requirement of 1 HF+1 Lecturer in addition to the UG is not available in 05 PG departments.
 - X. Professor is available only in 04 PG departments against the requirement of 06 departments.
 - XI. No. of patients in OPD are not available as per MSR.
 - XII. Required Bed occupancy in the hospital not available as per MSR.
 - XIII. Registrar or Senior Resident in clinical departments not available as per MSR.
 - XIV. At least one specialist doctor or one clinical is not available as per MSR.
 - XV. Requirements of equipment and instruments are not available in the hospital and college as per MSR.
 - XVI. Requirement of Hospital staffs are not available as per MSR.
 - XVII. Technical and other staffs are not available as per MSR.
 - XVIII. Operation Theatre not at all functioning.
 - XIX. Central lab. not available, X-ray machine was not working, USG machine is not available.
 - XX. Bio-Metric attendance system does not show the in and out time of the staffs.
 - 5. In view of the above deficiencies, as mentioned in para 4, you are hereby given an opportunity of hearing in terms of the provisions of the first proviso to sub-section (5) of section 13A of the IMCC Act, 1970, at ¹⁰:30AM on 02.08.2018, before the designated Hearing Committee in the Ministry of AYUSH to present your case and clarify the above position and to show cause as to why the permission of the college granted for a period of five years from the academic year 2016-17 to 2020-21, issued vide orders dated 07.09.2016, should not be withdrawn and also as to why the permission to take admissions for the year 2018-19 should not be denied to your college.
 - 6. It is pertinent to mention here that, to substantiate the authenticity of the documents submitted, in the above said compliance report, you are hereby requested to bring all the originals.
 - 7. It is further directed that you may make oral as well as written submissions before the designated hearing committee and produce all relevant valid documents/records/proof in original to substantiate your claims against all the deficiencies/shortcomings as indicated above and submit an authenticated copy for evidence/verifications by the Central Government as under:
 - i. The supporting documents may be the original/attested legible copies of the PG degree of the teachers/consented teachers, the attested copies of the experience certificates, the appropriate office order of the college for any reallocation, the attendance register up to Page 2 of 3

B 23/7/18 the visitation day, the time table indicating the engagement of the teachers, the details of the other duties as carried out by the teachers or any other documents related to availability of the teachers.

- ii. The supporting documents may be in original/attested legible copies of the degree of the hospital, non-teaching or other staff related to deficiencies mentioned above etc., the attested copies of the experience certificates, the appropriate office orders of the college for any reallocation, the attendance register up to visitation day, the time table indicating the engagement of hospital staff etc. or any other documents related to availability of the hospital staff etc.
- iii. The supporting documents may be with respect to the deficiency of OPD/IPD like central registration for maintaining the records of patients in OPD and IPD patients, laboratory and radiological investigation reports, IPD medicine dispensing registers, IPD diet register, duty rosters of hospital staff, birth and death certificates, etc. for the whole reporting year (2017) to substantiate the claim of genuine functional hospital fulfilling the norms as specified in sub-regulation (2) of regulations (7) of notified RMS.
- iv. The supporting/ relevant documents with respect to construction of college as well as hospital like architectural map/ proposed building Plan/ Zoning Plan/ Elevation Plan/ Department wise construction area as per RMS, 2016 and any other documents relevant to the deficiencies as indicated above.
- v. Similarly, the supporting documents may be with respect to other deficiencies like Instruments/Equipment's etc.
- It may please be also noted that in case you do not attend the hearing at the stipulated time and date, it will be presumed that you have nothing to say in the above said matter and further necessary action in terms of the IMCC Act and the relevant regulations will be taken based on available records.
